PEACE OFFICERS SWORN AFFIDAVIT WITHOUT MAGISTRATES WARRANT

Before me, the undersigned Notary / Magistrate, on this day, personally appeared the Affiant whose signature appears below, a Peace Officer for the State of Texas, who after being duly sworn upon oath, deposes and says that said Affiant has good reason to believe and does believe that the accused person:

Reeves, Roger Allen

Did, on or about the 3rd day of August, 2018 commit the offense of Aggravated Assault w/Deadly Weapon (Firearms) which offense as charged is classified as a Felony 2nd Degree, and is against the laws of the State of Texas.

The good reason and belief of the Affiant for this Affidavit is based upon the following facts and circumstances:

Details of Arrest:

Sgt. Shaw and Sgt. Cordova were summoned to respond to a reported shooting incident at PR 239 Fairfield, Freestone County, Texas. When Sgt. Shaw arrived, FCSO Patrol Deputies and Officers from other LE Agencies and detained multiple individuals and secured the scene. Sgt. Cordova had arrived at the location prior to Sgt. Shaw. Sgt. Shaw and Sgt. Cordova were informed by Deputies on the scene that the incident stemmed from an argument concerning a food stamp card between Defendant, Roger Allen Reeves, and another individual identified as Justin Baker Dear on (30) as further indicated that during the argument Justin Baker began striking Roger Reeve's car, a 2017 Charger with his fists, and one of his boots, which he had taken off. This resulted in a physical altercation between Roger Reeves and Justin Baker. During the physical altercation between Reeves and Baker, Roger Reeve's Brother, Richard Reeves joined in the fight, during which time he maneuvered behind Baker and placed him in a rear choke hold, which enabled Roger Reeves to punch Baker multiple times in the head with his fists. The fight continued, ultimately resulting in Roger Reeves retrieving a 9mm handgun and pointing it Baker. Roger Reeves then turned the gun away from Baker and pointed it at Baker's car, a Chevrolet Cavalier, firing 5 rounds and striking it 5 times. Sgt. Shaw and Sgt. Cordova proceeded to investigate the incident. As a result of the investigation, which consisted of obtaining Patrol Deputy's accounts, interviewing witnesses and suspects, processing the scene, and collecting evidence, it was determined that Defendant, Roger Allen Reeves, be arrested and charged with Aggravated Assault /w Deadly Weapon (TX PC 22.02) due to him having pointed the firearm at Justin Baker during the incident, prior to him shooting the rounds into Baker's car.. It was also determined that Justin Baker be arrested and charged with Criminal Mischief >\$2500; >\$30K because of him damaging Roger Reeve's car by striking it with sufficient force so as to inflict dents on the trunk lid and shatter the rear windshield. Following the physical altercation, Richard Reeves got into a Ford truck that was on the property and drove the truck in reverse, striking Justin Baker's car with sufficient force so as to move it from the gate where it had been parked by Baker in order to block the gate. Roger Reeves and Justin Baker were subsequently transported to FCSO Jail where they were booked in on their respective charges. Richard Reeves was taken to the hospital following the incident by Fairfield EMS for injuries sustained during the altercation. Richard Reeves was later discharged from the hospital. FCSO will continue an investigation of the incident at which time additional persons may be charged. The
