We have added you to the City Hall Visitor Parking list for today, at 11:00 am, DWU's administrative offices in City Hall 1500 Marilla, Room 4AN. Please see below parking instructions.

Dallas Water Utilities via garage

Dallas City Hall is located at 1500 Marilla Street. As our guest, you're welcome to park in the City Hall garage. The ramp to the underground garage is accessed from eastbound Young Street, between Field Street and Akard Street, from the left-hand lane. At the booth, give the guard your name and follow their directions to visitors parking. Enter through the visitors' doorway. Sign in with the security officer and pass through the magnetometer.

Follow the signs to the **GREEN** elevators and take an elevator to the 2nd floor. When you get off the elevator, you will turn toward the large painting. Follow the walkway left to cross the foyer, then turn left again towards the 2nd floor customer service lobby and security desk. Walk past the customer service windows on the right to the end of the lobby. You will then come to the **BLUE** elevators on your left. Take the blue elevator to the 4th floor and walk toward the glass doors with a **4A NORTH** sign above the doors. The attendant will let you in.
